Message from the Chair and Interim Executive Director

Sexual Assault Centre London continued on a journey in 2015-16 of creating possibilities for folks for London and Middlesex.

As we continued to create safe spaces for survivors of sexual violence to break their silence, the Boards of Women's Community House and Sexual Assault Centre London continued to explore the possibility of Unification. Guiding the discussion was the ultimate goal of "providing better services for people impacted by woman abuse and sexual violence."

In June 2015, both Board's agreed to move forward with creating a Business Plan and Transition Plan Development and had joint meetings throughout the year to review the progress.

This next steps included many, but at the forefront was developing more details around the programs and services plan and looking more closely at our infrastructure. A Programs & Services subcommittee was created to take a more in depth look at the conceptual model. Using co-creation, the committee was comprised of staff, volunteers and clients that had accessed our services. The recommendations were reviewed by the Board of Directors, staff and volunteers on May 24th, 2016.

On June 22, 2016 at the joint Board of Directors' meeting of Sexual Assault Centre London and Women's Community House both Boards unanimously agreed to become one organization.

A huge thanks is extended to our staff and volunteers. Their commitment and dedication has been unwavering and the exploration has not impeded day to day programs and services of the organization as you will see highlighted in the report. The Centre has continued to provide accessible and supportive services to the community.

London, ON - On June 22, 2016 at the joint Board of Directors' meeting of Sexual Assault Centre London and Women's Community House, both Boards unanimously agreed to become one organization!

Driven by the idea that better services could be provided for those impacted by woman abuse and sexual violence and after two years of careful study and relationshipbuilding across the two organizations, it was decided to move ahead and become a unified organization.

Over the coming months we will begin the integration process and will be moving toward full unification by October 31, 2016 with the public launch in January 2017.

Through our individual and group counselling programs as well as our 24 hour crisis and support line, survivors of sexual violence are supported on their healing journey. Free, confidential and non-judgmental individual counselling and support.

In 2015-2016, 52 women and girls received counselling services.


Girls Creating Change...


SACL also welcomed the news that the onetime funding received from the 2011 Sexual Violence Action Plan would be annualized as well making the total base funding \$436,452
